Ruby Vigneaux Dusek comes to us from south Louisiana where her family dates back to the Revolutionary War.

She has been active in the Spring Branch PTA and a Red Cross Disaster Volunteer since 1978. Currently Ruby is President of CLF and Parliamentarian of the Houston Genealogical Forum. She has served as a volunteer in the Archives of the Jesse Jones Medical Library researching Women Physicians in Texas before World War I and in Houston before World War II.

Fredericka Richter DeBerry is a native of Houston who was reared in Rosenberg. After graduating from High School there, she attended Austin College in Sherman. She has lived in various places in Texas and is currently a Librarian at Clear Lake High School where she has been since 1977. She is Secretary and Publications Chair and a member of the Board of Directors of the German-Texan Heritage Society.
