Mary Smith Fay Honored

am writing as I have to take exception to something printed on the front page of the recent (February 2003) CLF Newsletter. 

National Archives Problem Resolved

he conflict over several repeated and incorrect 1930 Census orders between the National Archives and CLF dating back to last September has been resolved. Currently, there is a 400 roll 1930 Census order by CLF at the National Archives. Unfortunately, due to the large number of mistakes made by the National Archives, they have changed their film manufacturing policy. Orders for less than a complete set have to wait until all complete set orders are finished. The CLF 400 reel 1930 Census order is not complete. CLF is terribly sorry and apologizes about this delay in CLF members not getting their film — some members having placed order as far back as June, 2002.

Nacogdoches Archives Find Announced

layton Library Friends acquisitions director Robert de Berardinis while pursuing finding aids for the Nacogdoches Archives, their translations, and transcriptions for Clayton Library, discovered that two boxes of original documents of the Nacogdoches Archives in the Texas State Archives had not been described in the Robert B. Blake collection, the University of Texas Calendar of the Nacogdoches Archives, nor microfilmed. CLF has had these documents filmed and with the assistance of volunteers from the Hispanic Genealogical Society is preparing a calendar with an English-language summary and index to these 540 pages of documents.

Coming: The Atascosito District Archives

t the March 25th CLF board meeting, Clayton Manager Marje Harris asked the CLF board to expand Clayton Library's already vast Texas holdings to include material from the early Anglo immigration period, 1816-1836, and all Texas county records beginning in 1836. Miss Harris also identified a number of manuscript holdings that had not been microfilmed and asked the board to determine if these holdings could be filmed. This is the same type effort recently completed by CLF director Robert de Berardinis for the never-beforefilmed portion of the Nacogdoches Archives. One of the manuscript collections of interest is the Atascosito District Archives, a collection of papers preserved at the Sam Houston Regional Library in Liberty, Texas. On April 17th, CLF board members Robert de Berardinis and Don Pusch traveled to Liberty to meet with Mr. Robert L. Schaadt, director of the Sam Houston Regional Library, to gather additional information about the collection and to examine some of the component papers.

During the Spanish and Mexican eras, the modern Texas counties of Liberty, Chambers, Jefferson, Orange, Jasper, Newton, Tyler, Polk, Hardin, and San Jacinto were part of the Atascosito district. From 1816 until 1831, the administrative seat was at the Atascosito post, located about three miles northeast of the present site of Liberty, Texas, on the old Atascosito-Nacogdoches Road. Many of the documents associated with the Atascosito District made

their way into the Hardin Family Papers, and these were later donated to the Sam Houston

Regional Library by Hardin descendents and a friend of the family. Dated prior to 1837, the papers have been designated as the Atascosito District Archives. As a finding aid for the collection, the Sam Houston Regional Library has a document-by-document calendar but no index. There are about 400–500 pages of material.

In addition to the Atascosito District Archives, there are a number of other pre-Republic manuscript collections owned by the Sam Houston Regional Library. Examples include the records of the Galveston Bay Land Company, whose records begin during the Spanish period and extend to almost the beginning of the War between the States. The totality of papers represented by this additional material is estimated to be about 400-500 pages. Mr. Schaadt indicated that a calendar of this supplementary material would also be available.

In coordination with Mr. Chris La Plante, Texas State Archivist, CLF plans to sponsor microfilming of the Atascosito District Archives and other pre-Republic collections owned by the Sam Houston Regional Library, both to ensure preservation of the collections and to make them available to Clayton



Library patrons. This will include microfilming the identifying folder of the manuscript, the manuscript, typed transcription (if one is in the folder), and typed translations (many Spanish documents have two translations). Where the original document is now illegible, earlier photocopies will be included on the microfilm as well. Estimated cost of the microfilming effort is \$600. Based on discussions with Mr. Schaadt and a review of portions of the collection, it appears that both the Atascosito District Archives and the supplementary pre-1837 material will be ready for filming sometime by the end of May. The actual filming would be accomplished in Austin by the Texas State Archives.

For further information about the Atascosito District, researchers should consult Miriam Partlow's Liberty, Liberty County, and the Atascosito District (Austin: Pemberton Press, 1974), shelved in the Liberty County, Texas, section at Clayton.


