PRESIDENT'S MESSAGE



On Sunday, March 1, 2009 a reception and "open house" welcomed donors to our recently renovated Clayton facilities. Over 125 people

filled the new Clayton Carriage House meeting facility to witness a significant donation by the Susan Vaughan Foundation to Clayton Library Friends in honor of noted physician and genealogist, Dr. Mavis Kelsey. The Dr. Mavis P. Kelsey Acquisitions Fund will be used to seed an account for future acquisitions for the Clayton Library and will grow with ongoing donations from interested parties. Tours of the newly renovated buildings yielded glowing comments and promises of future support.

Mayor Bill White formally opened the new facilities to the public on Monday, March 2, 2009. Several hundred people in attendance enjoyed docent led tours which highlighted the history of the complex and its planned use for genealogical studies, seminars, private and public events, as well as office space for the Houston Public Library Foundation during the renovation of their offices. Clayton Library Friends and Houston Public

Library are enjoying their partnership and look forward to future joint efforts to the betterment of our community. With respect to our recent renovation project, the board is pleased to announce that Clayton Library with Charlie Gardes, CLF Director and Construction Committee Chair, has received the Houston Business Journal's prestigious Landmark Award for the renovation of a historical facility.

CLF members will be gratified to learn that the loan to fund the renovation project has been paid in

President's Message

full. Although several outstanding renovation items remain to complete the interior of the facilities, the board felt, given current market conditions, it was prudent to pay off the loan as soon as possible to avoid further interest accrual. Future renovation-specific contributions and pledges will be directed to finishing up the remaining details and establishing a maintenance fund to assure our facilities do not again fall prey to the ravages of time and lack of necessary maintenance due to dwindling budgets.

Now we must return our focus to the long established goals of the Friends: acquisitions for the library. Karen Acker and John Dorroh, co-chairs of the CLF Acquisitions Committee have constructed an impressive team who possess extensive experience in the fields of genealogy, publishing, library science and research of various types of government and public records. We are fortunate to have such an elite committee whose prime goal is the assurance that Clayton Library remains one of the top genealogical research facilities in the United States. Please do not hesitate to make suggestions of record groups and publications which you would like to see added to the collection of the Clayton Library Center for Genealogical Research.

On March 14th, CLF welcomed the Ulster Historical Society of Belfast for a seminar on Scots Irish Research. Over 75 members and guests attended the conference replete with information and suggestions for locating ancestors of that region. Speakers Fintan Mullan and Dr. Brian Trainor were impressed with Clayton Library Friends' dedication to genealogy and have volunteered to return, giving us priority date selection. (They also enjoyed sharing a Tex-Mex dinner with several CLF members at the original Ninfa's Restaurant on Navigation before continuing on their tour of the U.S.)

Our next general meeting is scheduled for Saturday, May 16th at the Clayton Carriage House conference facility. Anthony Startz will speak on Spain's contribution to the American Revolution and how to locate your Spanish ancestors.

Spain's Contributions to the American Revolution and How to Research Your Spanish Patriot Ancestor

Mary 'Anthony' Long Startz

TOPIC: Spain's contribution to the colonist cause; archival resources in Mexico and Spain; and ongoing cataloging of 18th century Spanish resources in U.S. libraries and archives.



Mary 'Anthony' Startz is a native of Pensacola, Florida who has lived in Houston for more than thirty years. She has a Bachelor of Arts degree from Randolph Macon Woman's College, now Randolph College in Lynchburg, Virginia. Her business career has been in Human Resources in the fields of retail and manufacturing with the last eight years as Director of Human Resources for Lamons Gasket Company.

Anthony has two children. Her daughter Marion also shares her passion for volunteering, and son Will is a

sophomore at Loyola University Chicago majoring in history.

As an active member of NSDAR, Anthony found her first Pennsylvania Patriot here at Clayton in 1988 (way before internet research). She is currently on the board of Lady Washington Chapter NSDAR serving as Librarian, is Texas State Chairman Junior Sales and is National Vice Chairman for Units Overseas - Spain. Here is the connection to Spain. Anthony's sister Molly Fernandez de Mesa is Regent of the Espana Chapter in Madrid, Spain. Anthony and Molly first became involved in the search for more Spanish patriots and their records after a trip to the NSDAR New Mexico State Conference in 2005. Both serve on the Spanish Task Force of which the goals are to find and catalog records in archives, universities and libraries documenting Spanish patriots. While Molly searches records in Spain, Anthony shares the information with interested groups in the Houston area.

Sue Kaufman, originally from Chicago, Illinois spent her early librarian years beginning in 1987 in Peoria Illinois at the Peoria Public Library. After working in Peoria as the genealogy librarian, she moved to Fort Wayne, Indiana to work in the Genealogy Center of the Allen County Public Library. This collection is the largest genealogy research collection in a public library in the nation. She has been a genealogy librarian since 1987, moving to Texas in 2004. She graduated from Southern Illinois University/Carbondale with a degree in Administration of Justice, and attended Library School at Dominican University in Park Forest, Illinois. While in graduate school she had an internship at the National Archives - Great Lakes Region, and was a graduate assistant. She has worked in libraries since 1984, 24 years.

Susan began her Houston Public Library career as the manager of the Jungman Neighborhood Library on Westheimer, moving to Clayton Library in August of 2006. Her primary responsibilities include managing the unit, creating a vision for the future of the library, creating local, state and

At home Steven has three very cool cats to keep him company. Steven plays softball and ultimate frisbee every week to maintain his sanity."


Notes on Footnote.com

Can you name one website where you can access over 4.5 million digitized National Archives records, city directories from more than a dozen cities, many newspapers, and more? It is Footnote.com, an expanding website that can be accessed at all Houston Public Library locations. The site is listed under “Research,” then under “Genealogy,” from the HPL home page at www.hpl.lib.tx.us. Using a library computer, you can view and print out pages that pertain to your research. Using your own laptop at Clayton Library, you can view the records, but not print. From home, you can search the indexes for free but cannot access the images without a paid subscription.

From Footnote’s home page, take a brief tour of the site to get good tips for maximizing your time and effort there. Among the searchable records posted so far are some Civil War widows’ pension applications and some Union service records; Confederate amnesty papers; files of the Southern Claims Commission; Massachusetts printed vital records; some Texas birth and death certificates; the US Army Pension Index, 1861-1917; Revolutionary War rolls, service records, and pensions; George Washington’s correspondence; papers of the Continental Congress; several million naturalization records from California, New York, Maryland, and Massachusetts; selected records from the Pennsylvania Archives; and the complete land entry case files from Nebraska’s homestead patents of the Broken Bow land office.

Footnote allows visitors to search or browse the records. You can search for a specific name, but even with quotation marks around the name, you may or may not get appropriate hits, especially from the newspapers. My favorite example of this glitch was a search for my ancestor F.A. Mood. The highlighted newspaper “hit” was the word “mood” (as in a feeling) on the left side of a newspaper page and, from mid-page, the knee of a man’s trousers in an ad that the Optical Character Recognition (OCR) engine read as F.A.

However, the digitized Confederate Citizens File includes multiple pages on the Mood men. There I learned that F.A. Mood made and sold bridle bits and spurs to the Confederate cavalry. The receipts helped explain entries in this



preacher’s autobiography that mentioned “my factory” during the Civil War years. As found in another database, his father, Rev. John Mood, witnessed the bounty land warrant application of Revolutionary soldier Jeremiah Bunch. In U.S. Passport Applications, 1795-1905, for F.A. Mood, the Footnote.com database provides three pages, including a physical description, which is missing from the same database on Ancestry.com.

Perhaps the easiest way to use Footnote.com is to go first to the “original documents” and scan the list for a record group that sounds applicable or promising. Then search for an ancestral name within a specific database or choose a specific category (time period) or title in which to search or browse. Click on each result item to view the image(s). A handy feature is the “filmstrip” that contains all the related pages of your chosen result. Whether it is six pages of a military pension application or service record, or multiple pages of trustees’ records from the Bayland Orphan Home near Morgan’s Point and Baytown, you can advance the filmstrip easily with a click to browse or read more in the same set of records.

As with any website, Footnote.com has its unique layout and capabilities. The more often you visit, the more ancestral data you likely will find, especially since the site is continually growing.

Shelving Books - As spring begins anew, we would like to take this opportunity to renew our expression of thanks to one of our most steady and reliable sources of volunteer help over the years: our shelvers. These dedicated volunteers come to the library generally once a week for a couple of hours to assist with getting books back on the shelf and back in their proper order. This ensures that you can find the book you need, when you need it. As our materials usage statistics continue to increase, it becomes increasingly helpful to have



shelvers available to help manage the load, so that staff can be free to provide better customer assistance

to library visitors. Special thanks go to all of our “regulars”: Joy

Cowen, Norma Eriksen, Jean McLeod, Audrey Middlebrooke, Janice Shultz, Winona Wilkinson, and Gary & Robin Willis. We would also like to thank all those who help with shelving as the need arises. If you are interested in becoming a volunteer shelver, please contact Steven Bychowski, Volunteer Coordinator for more information on the next available training class. We encourage volunteers to commit to a 2-hour shelving time block on a weekly or bi-weekly basis.

Preparing for Inventory - Like working in the stacks? We are currently in the process of preparing our entire book collection for a long-overdue catalog inventory. Preparing for the inventory involves checking to make sure that each book has a scan-able bar code label inside (most older books do not), and making and inserting new scan-able bar code labels where needed. This will allow an HPL inventory team to go through each book and scan its bar code label, so that we can ultimately be sure that what we have in the HPL Online Catalog matches what we have on our shelves. This is a very important project for our library! It will also require a lot of volunteers, as it is a somewhat labor-intensive project,

but the work itself is relatively simple and can be done while comfortably seated at a table or desk. While we don't have any specific training dates set at this time, we would love to know how many people would be interested in helping us on this project. Acquisitions Committee Report

The Acquisitions Committee would like to report that we have been busily adding materials to Clayton's collections. Some of our most recent purchases have been 13 Uvalde County, Texas cemetery books, 24 Massachusetts vital records books to replace some of the older books that were in poor condition, and various county books for the "Book for Every County" project. We can now report that all counties of Alabama, Iowa, Louisiana, Massachusetts, Mississippi, New York, Ohio, South Carolina, Virginia and West Virginia are represented. We have been promised a book from Wheeler County, Georgia, which will complete that state. We have located and are in the process of ordering books for the seven Pennsylvania counties that are lacking books. We only need a book from Mitchell County, North Carolina, to complete that state. If anyone knows of a book that is available for Mitchell County, please let us know.

Five other states are very close to being complete. They are Arkansas, Illinois, Indiana, Kentucky and Tennessee. In some instances, finding a publication for a specific county is very difficult. With smaller, less populous, counties, all publications for the area are combined with one or more other counties. However, we will continue to search. Now the focus of this project needs to be directed toward the central and western United States, if the goal of having a book for every county in the U.S. is to be achieved.

The Committee has had some other requests from Clayton management and we will be proposing additional acquisition goals soon. We know we can count on CLF members to help when that time comes.

Spring Cleaning for Clayton

Did you know that many gaps in the Clayton Library periodical collection have been filled by the Friends’ “Duplicate Periodical Swap Program?”
